Free speech is protected by the Constitution of the United States. All attempts to limit free speech should be considered treasonous and should be punished to the full extent of the law.

The basic tenants of the "rule of law" require that for a law to be valid it must favor no one person or group over another AND it must be permanent. Temporary laws can easily be seen to favor one person or group over another based on the passage of time.

Perhaps the most flagrant abuse of the "rule of law" is the employment of various levels of taxation over time.
