I am a State House candidate who was just blasted by so called Issue Advocacy mailers from a group that does not have to disclose its donors to the public. I ran a campaign that very purposefully took a stand on money in politics, refusing PAC, out of state and party money. We were totally funded by grassroots donations from more than 700 ordinary citizens in my state (Michigan) and powered by countless hours of hard work and energy by myself and more than 300 volunteers of all ages and walks of life - an actual people powered campaign run with transparency, work ethic and honor.

And yet the playing field is so uneven that a 501c4 group from Georgia, the Faith & Freedom Coalition, was allowed to spend a hefty sum to influence a 1-county race nearly a thousand miles away in rural northern Michigan. Ralph Reed's F&F Coalition packed as many as 8 expensive attack mailers a day into local voters' mailboxes, etc. creating confusion and discouraging turnout in an obvious effort to influence the outcome of our local election.

My race is one example of a much, much bigger crisis in our entire democratic process. This crisis threatens the very future of our state and nation - who really "represents" us if elections continue to be determined by who can spend the most money, without any real transparency or accountability? If money is speech, this means those with the most money can drown out the rest of us.

Both liberal and conservative groups are currently exploiting the horribly weak "rules" for money in politics. We need the FEC to create and enforce rules with actual teeth, and with real consequences (loss of nonprofit status, for example).

We the citizens need you the enforcers to ENFORCE full and complete disclosure and transparency of every penny spent to influence voters in elections, including from 501c4 groups. We the citizens need you the enforcers to REMOVE the ridiculous, laughable veil of "issue advocacy" from these groups clearly acting to influence election outcomes. The rationale that allows this to continue is that the spending is somehow “independent.” But we know that Super PACs and others have many ways to coordinate with candidate campaigns – leading to inevitable corruption. FEC regulations need to rigorously define “coordination” to end the charade of “independent” expenditures.

Fair and clean elections, determined by the votes of American citizens, should be at the center of our democracy – not big money from secret sources. As long as dark money groups hide their funders and outside special interest groups can spend unlimited amounts behind the mask of “independent” spending, our democratic principles are at risk.

I urge you to restore transparency and enforce robust disclosure rules.
