With over 126 Million people reached through political ads and commentary on the internet during the last Federal election period, with no indication that those postings were paid for by an organization attempting to influence the outcome of elections -- particularly the presidency, the use of the internet has obviously become a tool for massive political persuasion requiring the same type of disclosures deemed necessary in print and broadcast media. To retain and sustain our democracy, as the Supreme Court long ago noted, "sunshine is the best disinfectant." To insure fairness and justice in our elections, those who would be influenced must be informed who is seeking to influence them.

Moreover, it will not be sufficient to merely require disclosure of the name of the organization that paid for the ad -- such as Internet Research Agency (IRA) -- since that as we now know through Congressional testimony will not provide information on who is behind the persuasion attempts: IRA was and is a Russian group clearly seeking to alter the outcome of U.S. elections. Simply naming the agency would not provide any useful disclosure. So it should be mandatory that disclosure of the payee's name be accompanied by disclosure of the affiliation, association and origin of the advertiser. Clearly drafted rules to this effect, once vetted through the administrative hearing process, will begin to insure that voters in future elections are aware of the sources seeking to parlay real or fake facts in an attempt to alter their views and voting.

Dear FEC:

I am writing regarding REG 2011-02 Internet Communication Disclaimers. I am requesting that you change the rules regarding online campaign ads to require disclosure, so the public will know who is paying for political ads on the Internet.

The Internet is the fastest growing medium for advertising and is expected to surpass television as the dominant advertising medium globally by 2020. Yet the FEC's antiquated regulations only require disclosure for television and print advertisements, not online ones. It is time for the FEC to move into the 21st century and extend disclaimers in political advertising to online political ads.

America has recently witnessed the hazards of failing to require disclosure. It was recently revealed that Facebook, Google and Twitter sold political ads to Russian trolls prior to the 2016 election. Facebook alone sold 3,000 political ads. Though an estimated 126 million Americans saw these ads, they didn't know that Russians paid for them because the ads did not include a disclaimer. If not for special counsel Robert Mueller's investigation, Americans may never have known. Although Facebook and Twitter claim they are going to implement voluntary rules for campaign disclosures, this is not enough. America needs a strong, binding federal regulation that will apply across the Internet, not weak voluntary rules that companies may fail to adequately enforce. The integrity of our electoral system is too important to leave to chance.

As U.S. Supreme Court Justice Louis Brandeis once said, "Sunlight is said to be the best of disinfectants." It is time to shine some sunlight on the Internet by requiring online campaign ads to disclose their funders.
